Academic Overview

Curriculum

The LL.M. curriculum is designed with an objective of moulding the candidates into research-oriented teachers, criminal lawyers addressing contemporary social change, technology infused entrepreneurs skilled in various facets of criminal law and legal start-ups etc. The curriculum is divided into four set of courses.

Mandatory Common Courses:

These include courses like Law and Justice in a Globalising World, Research Methodology, Comparative Public Law, Judicial Process and Dissertation. All the courses are 4-credit courses except dissertation which is an 8-credit course. These are compulsory papers which the candidate needs to study.

Specialized Core Courses:

These are specializations in criminal law which are essential for the program. It includes Criminal Justice Administration, Criminology, Sentencing process, Drug abuse and criminal justice system, International Criminal law, Corporate and White-collar Crimes, and Criminal Psychology

Discipline Specific Elective:

Any two Discipline Specific Elective can be selected from an array of 4 electives. All these electives deal with contemporary criminal jurisprudence.

Generic Elective:

The candidate may choose any 2 General Elective out of 4 available options. These electives are aimed at enhancing research, teaching and entrepreneurial skills of the candidate.
